

PINK WARRIORS 3x3 BASKETBALL TOURNAMENT RULES & REGULATIONS

1. EVENT BACKGROUND

- a. Pink Warriors 3x3 Basketball Tournament is a FIBA endorsed event in Singapore. Pink Warriors 3x3 (hereinafter referred to as the "Event") is organised by Jumpshot Singapore in partnership with Kallang Alive Sport Management Co Pte. Ltd. (KASM) (collectively referred to as the "Organisers" with its respective parent companies, subsidiaries, and affiliated parties).
- b. Season 3 of Pink Warriors 3x3 is back hoping to achieve greater heights within the basketball community. With the Singapore Sports Hub as our home court for Pink Warriors 3x3, the court is set for an even bigger and exciting event, the tournament promises an exhilarating showcase of skills, teamwork, and the undying passion for basketball. It is a celebration of sportsmanship, empowerment, and the spirit of camaraderie.
- c. There are six (6) categories in this tournament:

MALE	U13	Aged 11 to 13 years old in 2024. Born in 2011, 2012, or 2013.	
	U17	Aged 15 to 17 years old in 2024. Born in 2007, 2008, or 2009.	
	U21	Aged 18 to 21 years old in 2024. Born in 2003, 2004, 2005, or 2006.	
	OPEN	Aged 22 years old and above in 2024. Born in the year of 2002 or earlier.	
FEMALE	U13	Aged 11 to 13 years old in 2024. Born in 2011, 2012, or 2013.	
	OPEN	Aged 14 years old and above in 2024. Born in the year of 2010 or earlier.	

d. For more information on Event schedules and format, please refer to **Annex I**.

2. ELIGIBILITY

- a. Each player is allowed to register in only one (1) Team with a maximum of four (4) players.
- b. Only players with a confirmed FIBA account are allowed to participate. Players can create an account on play.fiba3x3.com
- c. There are no restrictions on the nationality, anyone with a valid Visa Entry to Singapore can form a team to participate in the Event.







- d. Eligibility for each category is based on the birth year based on Clause 1.C
- e. The Organisers will not be responsible or in any way liable in the event of any dispute arising between the player(s) and / or any organisations.
- f. Participants must be physically fit and are not suffering from any chronic or infectious diseases that may endanger other participants.
- g. The Organisers reserve the right to reject the registration of any team or player(s) at its discretion.
- h. Upon entering the Event, participants must agree and accept all rules, procedures, and terms (collectively or separately referred to as "the Rules"). The Organisers reserve the right to disqualify any players or teams for infractions of tournament rules and policies.
- i. In the event of any question or matter arising in relation to eligibility of player(s), which is not expressly provided for in any of the rules governing this tournament, the decision made by the Organisers will be final.

3. COMPOSITION OF TEAMS

- a. Each category is open to twelve (12) teams' participation, with only one (1) Champion Team per category.
- b. Each team will comprise of a minimum of three (3) players and up to a maximum of four (4) players. Only three (3) players will be allowed on the court. Strictly no coaching is allowed during the tournament. Every player must be available for each game and be able to produce their original photo identification document for verification.
- c. Each team must assign a Team Captain or Team Liaison who will be the Point of Contact ("POC") with the Organisers on all tournament related matters. It is the teams / players' own duty to be familiar with the Rules & Regulations governing this tournament.

4. REGISTRATION REQUIREMENTS

- a. Information on the Event may be found on Jumpshot Singapore's Official website at https://jumpshot.sg/.
- b. Registration Fee for all Categories, except Boys & Girls U13, is \$100 per team. The registration fee is non-refundable and must be paid upon registration on Jumpshot Singapore's official website.
- c. Registration Fee for U13 Boys & Girls is \$50 per team.
- d. Registration period: 8 February 2024 to 8 March 2024, 2000 hours.
- e. Early Bird Registration Price of \$88 is only eligible to successful registrations made between 8 February 2024 and 12 February 2024 2359 hours.







- f. Teams who have successfully registered for the Event will be announced on the Jumpshot Singapore official website on 9 March 2024.
- g. All players' names in each team must be provided upon registration. No substitution, de-registration or inclusion of players will be allowed after the closing date of registration unless otherwise approved by the Organisers in writing.
- h. The team's name shall comply with the principle of public order and good custom, shall not contain slander, discrimination, or infringement of interests of any third party, and shall not be randomly changed. In addition, the team's name shall not be identical with or similar to the name, trademark, trade name and product name of any well-known enterprise (except for legally authorised names or self-owned trademarks). For any team name deemed as inappropriate by an Organiser, teams shall make immediate alteration.
- i. It is the sole responsibility of Team Captain or Team Liaison to ensure their players are only registered in one (1) team. Submission of ineligible players may render the team to be disqualified from the tournament at the discretion of the Organisers.
- j. Any foreign player in the team must be a holder of a valid passport and ensure that they meet or possess entry requirements as stated by the Singapore Immigration and Checkpoints Authority (ICA).
- k. Each participant is required to have his/her own insurance (health and accidental). The Organisers and all its respective appointed vendors, agents and employees will not be liable for any injury, accidents, or mishaps throughout the duration of the Event.

5. PRIZES AND AWARDS

- a. Medals will be awarded to the top 2 teams for all categories.
- b. Cash prize will be awarded to top 2 teams for all categories, except for U13 Boys and Girls, as follows:
 - i. Champion: \$800/category;
 - ii. Runner up: \$600/category.
- c. The top 2 teams awarded must be present for the prize presentation ceremony.
- d. All players must be properly attired when attending the ceremony (team uniforms and covered shoes). No slippers or sandals are allowed.

6. TOURNAMENT PRECAUTIONARY TERMS

Organised By:

i. The Organisers, at their discretion, reserve the right to determine the date, time, and venue of the fixtures for the tournament. All teams shall abide by Organisers' arrangements, and teams shall not







- raise objections regarding the arrangements. Teams will concede a walkover, if they fail to turn up twenty (20) minutes before the scheduled warmup time.
- ii. It is mandatory for teams to prepare two (2) sets of **numbered jerseys**: dark and light (white only). Teams must wear identical coloured shorts and tops. Light tops and dark shorts are allowed.
- iii. If for any reason the team is unable or voluntarily gives up their rights to participate in the next round, the Organisers reserve the right to substitute the team with another team based on its ranking in the tournament.
- iv. The Organisers reserves the right to impose punishment or disqualification including but not limited to revoking all team players from participating in any tournaments held by Jumpshot Singapore.
- v. No substitution is allowed for the team, in the event one of the team's players is disqualified.

7. RIGHTS EXEMPTION

- i. On entering the tournament, participants agree to irrevocably and perpetually grant each of the Organisers and its respective designated parties the right to use all the personal information and all other materials provided or generated by participants in connection with the Event in an unconditional and free manner, including but not limited to participants' name, stage name, portrait, photos taken on site, videos, interview records, comments and remarks on the Event, team names, marks, team logos (hereinafter referred to as "Materials")
- ii. The usage of Materials includes but is not limited to copying, editing, encoding, storage, recording, distribution, rental, exhibition, screening, performance, broadcast, online dissemination, filming, adaptation, translation, compilation and modification. Each of the Organisers reserves the right to delete the Materials during or after the Event and is not responsible for returning them in any form.

8. CONFLICT OF RIGHTS

i. Teams/participants are not allowed to arrange/enter into any commercial endorsement agreement with any brands or participate in any brand endorsement activities during the Event without prior written consent from the Organisers. Failure to do so may result in a team's disqualification and the Organisers are not responsible for any direct or indirect losses caused thereby.

9. SUPPLEMENTARY RULES

- i. If the Event is cancelled or postponed due to rule or order from government or judicial authority whether valid or not or any other cause beyond the reasonable control of any Organiser, the Organisers shall notify the Team Captain or Team Liaison accordingly of such postponement or cancellation.
- ii. The Rules and Regulations are accurate at time of print. The Organisers reserve the right to amend the said Rules and Regulations at any time as it deems fit. The Organisers reserves the right of final interpretation on all the rules, procedures, and annexes.
- iii. No refunds or transfers will be made once payment has been collected or registration has been confirmed. Unless otherwise stated in these Rules & Regulations or by the Organisers, no







compensation will be made under any circumstances, including inclement weather or failure to show up for the Event.

10. DECLARATION AND GUARANTEE

All teams, participants and team staffs hereby abide by the terms and commit as follows:

- i. I shall fully comply with the Rules and Regulations during my participation in the Event.
- ii. I hereby declare all registered information to be accurate and complete. I am able to present my identification to the Organisers prior to the Event for verification purposes. I understand providing false, misleading or inaccurate information about my team and myself may be disqualified from the tournament.
- iii. I hereby declare I am physically fit to participate in the Event and am not suffering from any chronic or infectious diseases that may endanger other participants.
- iv. I shall not breach any Rules and Regulations under law application and no infringement of third-party rights.
- v. I hereby declare that I am aware of all potential risks of the Event, including the risk of causing bodily injuries, voluntarily participate in the Event, and agree to accept such potential risks.
- vi. I agree to sign Release and Waiver of Liability and Indemnity Agreement of Participants prior to the event (Annex II, hereinafter referred to as the "Release and Waiver", which will be signed during team on-site check in) and deliver the signed Release and Waiver to the Organisers.
- vii. I will assume the responsibilities of all risks arising from participation in the Event. I will not hold the Organisers liable for any loss, damage or cost arising from participation in the Event.

Tournament Format : Group Round Robin – teams advance to Quarter Finals

Quarter Finals – 4 Teams advance to Semi-Finals

Semi Finals Finals

At the end of each game, Team Captain from both teams shall review and sign the official scoresheet as verification that the game score and winning team are accurate. Failure to complete this process immediately upon conclusion of the game will be considered an acknowledgment that the score is final and the winning team has been accurately recorded. Once the game results are determined, the recorded result is not subject to change unless approved in writing by a designated tournament official.

A. GAME RULES

- i. Games are played in 10-minute quarters net time. The game clock will not stop during dead ball situations and free throws.
- ii. ONLY three (3) players from each team are eligible to play on the court at any given time.
- iii. Timeouts There will be no timeouts throughout the games.
- iv. Tiebreaker Rule an overtime shall be played. The first team to score 2 points in the overtime wins the game.
- v. 3-point logo shot/s will be implemented to encourage more long-range shooting and add an extra layer of excitement to the game.
- vi. FIBA 3x3 Rules of the Game will be implemented.

B. GAMES SCHEDULES

a. The schedule will be sent via email to all team captains at least two days prior to the event, i.e. on or before 14 March 2024, and the schedule can be found on Jumpshot Singapore's Official website at https://jumpshot.sg/.

Annex II

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT







PARTICIPANT: PLEASE READ CAREFULLY BEFORE SIGNING. THIS DOCUMENT HAS LEGAL CONSEQUENCES AND WILL AFFECT YOUR LEGAL RIGHTS AND ABILITY TO BRING FUTURE LEGAL ACTIONS

IN CONSIDERATION of being permitted to participate and/or perform in the basketball game(s), event(s), contest(s) (each, a "Contest") and other activities scheduled to take place at the events known as Pink Warriors 3x3 Basketball Tournament held on 16 to 17 March 2024 (collectively, the "Event"), the undersigned, on behalf of myself, my participant child or ward (if applicable) (the "Participant"), and Participant's personal representatives, heirs, assigns, and next of kin, hereby:

- 1. (a) agrees that prior to participating and/or performing, Participant will inspect the facilities and equipment to be used, and if Participant believes anything is unsafe, Participant will immediately advise an official of such conditions(s) and refuse to participate until such condition(s) is corrected; (b) acknowledges and fully understands that Participant will be engaging in physical activities that involve the inherent risk of serious injury, including permanent disability and death which might result not only from Participant's own actions, inactions or negligence, but from the actions, inactions or negligence of Jumpshot Singapore, and its member teams (and each of their respective administrators, designees, coaches, officers, directors and employees), other participants, operators, vendors, sponsoring agencies, sponsors, advertisers, and owners and lessees of premises used in connection with the Event (that shall include Kallang Alive Sport Management Co Pte. Ltd. and its employees, contractors, agents and affiliates) (collectively, the "Released Entities"), the rules of play of the Event, the condition of the premises or of any equipment used and other risks not known to Participant or not reasonably foreseeable at this time, and Participant understands and voluntarily assumes all risks and responsibilities of participating; (c) represents and acknowledges the Participant is in good health and is not restricted in any way from participating in the Event because of Participant's health; (d) represents and acknowledges the Participant understands and will comply with all of the rules of play, guidelines, schedules, policies, conditions of entry and instructions pertaining to the Event and the premises of the Event and shall be fully responsible for all consequences of Participant's acts or omissions in violation of any of these rules of play, guidelines, schedules, policies, conditions of entry or instructions; and (e) fully agrees that the Released Entities are permitted (but not obligated) to provide medical care to the Participant if and when the Released Entities deem it necessary to do so;
- agrees to and does hereby release, waive and forever discharge the Released Entities from all liability and claims for damages for death, personal injury or loss or property damage which Participant may have or which may hereafter accrue to Participant, as a result of Participant's participation in or otherwise in connection with the event, and which may be asserted by Participant or on Participant's behalf against any of the released entities;
- 3. agrees to hold harmless, defend, and indemnify each of the Released Entities from any loss, liability, claim, damage, judgment, legal fees, or costs arising from or incurred due to Participant's participation in or otherwise in connection with the Event, whether caused by the negligence of any Released Entity or otherwise;
- 4. represents and warrants that Participant's acts, poses, words and performances at the Event will be in good taste and will not reflect negatively on the image, reputation or business of the Released Entities, and grants full permission to each of the Released Entities (and each of their designees, agents and licensees), with no obligation to compensate Participant, for purposes of utilizing Participant's name, voice, statements, image, likeness, biographical data and/or actions in any live or recorded audio, video, film, or photographic display or other transmission, exhibition, publication or reproduction made of, or







at, the Event in any medium, whether now known or hereafter created, or context, without further authorisation or compensation, and that Participant has the right to grant such permission;

- 5. agrees to relinquish, give, and assign to Released Entities all right, title, and interest that the Participant may have in the finished pictures, finished product, recordings, negatives, digital images, reproductions, copies of the original recordings, prints, derivative works, advertising, or other materials that may be used in connection therewith relating to Participant's participation in or otherwise in connection with the Event, and further irrevocably and perpetually grant the Released Entities the right to give, sell, transfer, and exhibit such finished pictures, finished product, recordings, negatives, digital images, reproductions, copies of the original recordings, prints, negatives, derivative works, advertising, or other materials that may be used in connection therewith to any responsible individual, business, firm, publication, or to any of their assignees and agrees to provide reasonable assistance to Released Entities needed to perfect or secure any of the Released Entities' rights (if necessary);
- 6. understands and agrees that (a) Participant's refusal to accept any prize from any Contest, the Event or other activity shall constitute a forfeiture of that prize and shall release the Released Entities from any and all obligations in connection with such prize; (b) Participant is responsible for and shall pay all applicable taxes on any and all cash and/or prizes Participant wins; (c) Participant will indemnify and hold the Released Entities harmless against any liability for any such taxes and agree that any of the Released Entities may deduct or require payment of any such tax before delivery of a prize; and (d) any travel undertaken by Participant in connection with Participant's acceptance or use of any prize shall be taken at Participant's sole risk; and
- 7. expressly agrees that (a) this release and waiver of liability and indemnity agreement is governed by the laws of Singapore, and the Singapore courts shall have exclusive jurisdiction to deal with any disputes arising in relation to this agreement. If any portion of this agreement is held invalid, it is agreed that the remaining provisions of this agreement shall nonetheless continue in full legal force and effect.

Participant has read and voluntarily signs this release and waiver of liability and indemnity agreement, understands its terms, including that Participant is hereby giving up substantial legal rights, and further agrees that no oral representations, statements or inducement contrary to anything contained herein have been made by the released entities. Participant represents that participant is eighteen (18) years of age or older, and participant (or the guardian of participant, where Participant is under eighteen (18) years of age) acknowledges that each of the Released Entities is relying on the grant, release or waiver of rights (where applicable) contained herein.
