ACKNOWLEDGEMENT, RELEASE AND INDEMNITY

This is an important document which affects your legal rights and obligations. You are required to read it carefully prior to entering the event. Please read this form prior to the event to be aware of the risks of participating.

In consideration of Jumpshot Arena Pte Ltd ("Organiser") accepting my participation in **PINK WARRIORS 3X3 SEASON 5** ("Event") to be held at Somerset Youth Park, 121 Somerset Rd, Singapore 238166, I agree to this release of claims, waiver of liability, and assumption of risk.

1. I have read and understood the Rules and Regulations relating to the Event.
2. Each of the Event Organiser may, at their sole discretion, refuse entry or cancel an entry to any person for any reason whatsoever.
3. I understand the demanding physical nature of the Event. I declare, as a condition of entry to the event, that I have sufficiently trained for this Event and that I am not aware of any illness, injury or any other physical disability which may cause me injury or death whilst participating in the Event.
4. In the event that I become aware of any medical condition or impairment, or am otherwise sick or injured prior to or during the Event, I will withdraw from the Event.
5. I acknowledge that by participating in the Event, I am exposed to certain risks.
6. I acknowledge and understand that whilst participating in the Event:
 - a. I may be injured, physically or mentally, or may die from various causes, including, but not limited to overexertion, dehydration, cardiac arrest, slips, trips or falls, accidents with other participants, spectators and road users, or accidents caused by my own actions;
 - b. My personal property may be lost or damaged;
 - c. I may cause injury to other persons or damage their property;
 - d. The conditions in which the Event is conducted may vary without warning.
 - e. There may be no or inadequate facilities for the treatment or transport of me if I am injured;
 - f. I assume the risk and responsibility for any injury, death or property damage resulting from my participation in the Event.
 - g. I agree that if I am injured or require medical assistance, the Event Organiser may, at my cost, arrange medical treatment and emergency evacuation as deemed necessary. I agree that I am responsible for my own medical and ambulance insurance cover.
7. I agree to release, indemnify and hold harmless the Event Organiser, its officers, employees, agents, volunteers, contractors, public bodies, landholders, shareholders, and sponsors, from and against any and all claims, demands, right or cause of action, suits, expenses, costs and proceedings of any nature whatsoever which may be made by me or on my behalf or by other parties for or in respect of or arising out of any injury, loss, damage or death caused to me or my property as a result of my entry or participation in the Event whether by negligence, breach of contract or in any way whatsoever.

8. I also agree that, in the event I am injured or my property is damaged, I will bring no claim, legal or otherwise, against the Event Organiser, its officers, employees, agents, volunteers, contractors, public bodies, landholders, shareholders, or sponsors in respect of that injury or damage.
9. I understand that my medical history and personal information, collected as part of the entry process for the Event will be made available to the event medical team and operations team. It will only be used to help staff look after me if I need help and care. If I am evacuated from the event by Emergency Services, this personal information plus any new data entered by event staff will be supplied to the Emergency Services staff to enable my continued care.
10. I agree to allow my name, results, photographs, videos, multimedia or film likeness to be used for any legitimate purpose by each of the Event Organiser, the sponsors, event partners, or assigns without payment or compensation.
11. I acknowledge that my image and video will be taken by an Event photographer and videographer and I consent for the images and videos to be used by each of the Event Organiser on their social media and for other promotional materials.
12. I agree to abide by the Event Rules and Regulations, and the directions of all Event officials.
13. I acknowledge that the Event Organiser may change the event without notice if the Event Organiser deem necessary. I also acknowledge that the Event Organiser may cancel the Event due to weather conditions, safety considerations, terrorism or 'acts of god' and that in such circumstances my participation will be cancelled.
